## Voucher for a one-day ticket

The stand rental fee includes an unlimited number of redeemed vouchers for a visitor day ticket.

## AUMA fee

The Association of the German Trade Fair Industry (AUMA) charges all exhibitors a fee of 0.60 EUR/m<sup>2</sup> of rented exhibition space. This fee is calculated by YONTEX and paid directly to AUMA.

## Flat-rate waste disposal fee

The obligatory flat-rate waste disposal fee of EUR 6.80/m<sup>2</sup> covers the disposal of waste generated by the exhibitor on his stand during set-up and dismantling and for the entire duration of the trade fair. The disposal of production waste, entire stand elements, hazardous waste and complete exhibition stands is excluded from this.

## 5. Exhibitor services

Exhibitor services can be ordered online via our exhibitor portal and the partner shops. Contracts for exhibitor services are not concluded with YONTEX, but with the exhibition centre operator or service partner specified in the order.

Closing date for orders: Please note the deadlines stated in the respective online exhibitor shops at drinktec.

The contractual partners reserve the right to charge a fee or surcharge for late receipt of orders.

## 6. Exhibitor passes, invitation vouchers, identity checks

For the duration of the trade fair, each exhibitor will receive the following number of free exhibitor passes for their stand:

In the hall

up to 20 m<sup>2</sup> stand size

3 exhibitor passes

from 21 m<sup>2</sup> for each additional 10 m<sup>2</sup> or part thereof

1 exhibitor pass (additional)

from 101 m<sup>2</sup> for each additional 20 m<sup>2</sup> or part thereof

1 exhibitor pass (additional)

Additional exhibitor passes can be ordered for a fee. The Exhibitor passes are intended for stand personnel only; they may not be passed on to third parties. All information provided during the personalisation process of the exhibitor pass must be truthful. In the event of misuse, YONTEX is authorised to confiscate the exhibitor pass. The inclusion of co-exhibitors increases the number of exhibitor passes not.

The exhibitor pass does NOT entitle the holder to free use of local public transport.

Exhibitors will receive free e-codes to allow trade visitors or business partners free admission. The provision of invitation vouchers against payment is not permitted. Any misuse will result in the cancellation of the invitation vouchers.

## 8. Assembly and dismantling

You will receive more detailed information with the traffic guide (no later than 8 weeks before the start of the trade fair).

On the last set-up day, 14 September 2025, all delivery and set-up vehicles must be removed from the halls and outdoor exhibition area by 17:00. Vehicles that are still in the halls or outdoor exhibition area after the aforementioned times will be removed at the risk and expense of the respective exhibitor. Decorative set-up on the exhibitor's own stand area is possible until 20:00.

An extension of the set-up time is only permitted in exceptional cases with the prior written consent of YONTEX.

Please note that containers and exhibits may only be placed in the loading yards from 18:00 on the last set-up day.

YONTEX must be informed in advance if set-up begins later than 12:00 noon on 14 September 2025.

The set-up work must be completed by 18:00 on the last set-up day at the latest. The surrounding aisles must be clear by this time.

Admission for stand construction companies and suppliers for dismantling will not begin before 17:00 on 19 September 2025.

**Truck check-in during set-up: Trucks** over 7.5 tonnes must report to the truck check-in on site. You will receive further information in the traffic guide.

Night work permit: required for work during the set-up times from 22:00, on the last set-up day from 18:00 or during the running time within the night closing time, i.e. outside the opening hours for exhibitors (Friday: 08:00 - 20:00, Saturday: 09:00 - 20:00, Sunday: 09:00 - end of dismantling). A flat fee is payable per exhibitor, which must be paid on site.

## 9. Stand design

The stand design concept must be adapted to the rented stand type (block, head, corner, row stand). Under no circumstances may stand limits be exceeded compared to the authorisation.

Stand sides facing neighbouring stands must be kept neutral, white, clean and free of installation material from a construction height of 2.50 m upwards.

All exhibitors are advised to erect partition walls (height 2.50 m) at the boundary to neighbouring stands. Partition walls will only be erected at the request and expense of the exhibitor. Partition walls or additional bunk walls (height 2.50 m) can be ordered in the exhibitor portal.

Attention must be paid to an open stand design. This means that the erection of closed walls at the edge of the stand (up to and including 2 metres indented) is permitted if these do not take up more than a maximum of 50% of the respective stand side.

A continuous closed wall must not exceed a maximum length of 6 metres. After a closed wall length of 6 metres, a passage width of at least 2 metres must be maintained. YONTEX reserves the right to authorise exceptions to these regulations in justified individual cases. Optionally, a balustrade with a maximum height of 1.10 m can be erected over the entire length of the side to be closed. The 50% rule described above also applies to the construction height above this. Deviations are only permitted with the written consent of the neighbouring stand on the opposite side. Furthermore, the Technical Guidelines of Messe München apply.

The exhibitor undertakes to install walls on all closed sides of the stand area and to provide a floor covering.

The exhibitor must take into account the character and appearance of the trade fair. YONTEX is authorised to prescribe changes to the stand design at its reasonable discretion.

Exhibitors or their stand designers must inform themselves about the technical conditions and record the exact dimensions before starting the planning work. If necessary, floor plan sketches of the stand areas with the immediate surroundings and dimensions can be requested from YONTEX, but no guarantee can be given for their accuracy.

## 10. Building and advertising heights

Single-storey construction:

The maximum construction height is 7.50 m. The advertising height (top edge) is 7.50 m.

Two-storey construction:

The maximum construction height is 7.50 m. The advertising height (top edge) is 7.50 m.

A distance of 2.00 m must be maintained between advertising media and the neighbouring stand. An exception applies if the advertising is not directed towards the neighbouring stand in any way. Advertising stands may not be designed with flashing or changing lights.

Please observe the maximum construction height on the hall walls (see hall and outdoor area description).

## 11. Plan approval, public law regulations for exhibition stands

In principle, each organiser of an exhibition stand is responsible for its design, construction and operation as well as for compliance with public-law regulations, insofar as these apply to exhibition stands, the Technical Guidelines of Messe München GmbH and the YONTEX Terms of Participation.

If the following requirements are met, a plan approval by YONTEX is not necessary:

- Maximum stand and advertising height is 3 metres
- Stand size smaller than 100 m<sup>2</sup>
- No stand cover available.

Stand concepts deviating from the above specifications must be submitted no later than 6 weeks before the official start of stand construction with true-to-scale stand design plans (floor plans, elevations and sectional drawings).

- to Messe München GmbH, Technical Exhibition Services Division, for approval.

This applies in particular to large LED walls.

Suspensions from the hall ceiling are generally carried out by the responsible contractors of Messe München GmbH. In addition, multi-storey stands and special structures (e.g. bridges, stairs, cantilever roofs, galleries, etc.) are generally subject to approval.

Exhibition stands requiring approval or planning permission may only be erected in accordance with the approved plans or authorisation and in compliance with any conditions imposed by Messe München GmbH. Approval or authorisation does not release the stand constructor or exhibitor from his responsibility for stand safety and compliance with the above-mentioned requirements, unless he has been expressly exempted from these requirements.

Further information can be found in the "Building regulations" in the Exhibitor Shop under "Information sheets - Applications". Please always observe the requirements of the Technical Guidelines and the information in the individual information sheets. For further processing, the exhibitor service forms for ordering additional stand services will be made available to you in good time via our online Exhibitor Shop.

## 12. Marketing fee for main and co-exhibitors

The marketing fee is obligatory for all contractual partners - main exhibitors and co-exhibitors - and will be invoiced by YONTEX in addition to the participation fee. The price for the marketing fee is € 1,400 and includes the following services:

Presentation of the exhibitor:

- Entry in the exhibitor and product directory\* at [www.drinktec.com](http://www.drinktec.com):
  - Entry of company name, address, hidden e-mail address, contact person and logo
  - Presentation of 1 product or service with one photo, one PDF, one video (link) and a maximum of 2,000 characters of text in each case
  - Classification into 5 product groups (product directory)
  - One entry each in the Business Directory, Export Directory, Solutions Directory and Innovation Guide (subject to review)
  - Company description (maximum 2,000 characters)
  - Link from the trade fair website to the exhibitor website. The exhibitor places a counterlink.
  - Social media buttons incl. linking
  - Entry in the print trade fair guide (company name, stand number, logo)
  - Publication of press releases from the exhibitor in the press section of the website at [www.drinktec.com](http://www.drinktec.com).
- \*The extended basic entry is entered and published after admission and contains the company name, postcode, city, hall and stand number.

Further entry options, e.g. in the list of goods and other presentation options in these media, will be offered to exhibitors separately via the exhibitor portal after the exhibitor has been admitted.

The Media Services Partner shall handle these additional entry options with the applicant in its own name and for its own account. YONTEX assumes no liability for the correctness and completeness of the official trade fair media.

Other than the official service providers named on the drinktec website and in the exhibitor portal, YONTEX is not authorised to create the official trade fair media. After registration, YONTEX will transfer the company data submitted with the registration to the responsible service providers for inclusion in the official trade fair media.

The contractual partner is solely responsible for the timely provision and, if necessary, maintenance of the content to be stored in the respective media package or in the respective entry ("profile" of the contractual partner, contact person).

The contractual partner is solely responsible for the content of the profiles or the respective entries and any resulting damage. The contractual partner shall be responsible for the content and the legal admissibility of the image and text documents provided or posted for the profiles and entries. The contracting party shall guarantee that the content provided by it does not infringe any industrial property rights or other rights of third parties. YONTEX shall not be obliged to check whether the content entered or provided by the contracting party infringes or may infringe the property rights or other rights of third parties.

Should third parties assert claims against YONTEX due to the legal or competition law inadmissibility of the entries, then the Contractual Partner shall indemnify YONTEX comprehensively against all claims asserted, including all costs of necessary legal defence on the part of YONTEX. The same shall apply to entries by exhibitors, co-exhibitors and exhibitors on joint stands which the respective exhibitor publishes in the official trade fair media which initiated YONTEX.

YONTEX reserves the right to refuse the publication of content due to its technical form or for objectively justified reasons if, in YONTEX's reasonable judgement, the content violates laws, official regulations or common decency or if its publication is unreasonable for YONTEX. YONTEX shall take into account not only the content but also the overall visual appearance of the content from a qualitative and aesthetic point of view. The contracting party shall be notified immediately of any refusal to publish.

YONTEX does not guarantee that the profile and content will be available securely and error-free at all times.

### 13. Trade fair advertising space

Advertising spaces located on the venue grounds are managed by Messe München GmbH.

### 14. Driving, transporting and parking

Special transports require the timely written authorisation of YONTEX. The provisions of the German Road Traffic Regulations (StVO) apply mutatis mutandis when driving on the exhibition grounds. Access to the halls is only permitted for loading and unloading vehicles. Upon completion of the loading process, vehicles must be removed from the loading yards immediately and moved to the designated parking areas. Marked driveways, fire brigade movement areas, escape routes, etc. must be kept clear at all times. Lorries over 3.5 t may only be parked in the designated parking spaces during the trade fair (subject to a charge). Illegally parked vehicles may be towed away by YONTEX at the vehicle owner's expense.

### 15. Technical equipment

All electrical equipment, systems and installations must comply with the VDE regulations and local regulations. Electrical installations may only be carried out, connected and checked by companies authorised by the venue operator.

### 16. Volume limitation for background music

The volume must not exceed 60 dB(A) at the stand boundary. In all other respects, reference is made to Section 18 of the General Terms and Conditions of Participation of YONTEX GmbH & Co.

## 18. Sales regulation

Sales are only permitted to commercial resellers, commercial buyers or bulk buyers. Hand selling and price labelling of the exhibited products are prohibited.

This applies for the entire duration of the trade fair and expressly also for the last day of the trade fair. In addition, hand-selling is a violation of the trade police regulations. Exhibition goods may only be delivered to the buyer after the trade fair has closed.

In the event of culpable violations, YONTEX is entitled to block the stand and to demand a contractual penalty of 15 per cent of the invoiced stand rent for each prohibited hand sale.

## 19. End of fair

The fair ends on 19.09.2025 at 17:00.

The stand must be staffed until the official end of the trade fair. A contractual penalty of € 2,000.00 shall be payable in the event of culpable infringement.
